CBD BUG amendment proposal for Annerley Road Peak Hour Bike Lane Trial

I refer to the 17 June 2015 meeting to discuss the Brisbane City Council's plan for the Annerley Road Peak Hour Bike Lane Trial that was attended by Brisbane Central Business District Bicycle User Group (CBD BUG) representatives.

This letter is now provided as follow-up to this this meeting and to formalise the CBD BUG's views on this project.

The CBD BUG's overall view of this project is that it is another step towards encouraging a broader range of people within the community to use bicycles for transport. With Annerley Rd being Queensland's worst black spot for cyclists crashes it is clear this thoroughfare urgently needs upgrading to provide additional safety for people riding bikes. In this respect the CBD BUG ultimately would like to see protected bikelanes provided along Annerley Rd. Whether this is in the form of single direction protected bikes lane on each side of the road or a protected bide directional bike lanes on one side of the road is a decision for council.

In relation to the technical details of this project's implementation, the CBD BUG would in particular like Council to include a protective barrier for the city-inbound bike lane to physically separate people riding bikes from motorised traffic. This can be achieved by moving the parallel parking for motor vehicles out from the kerb and placing the bike lane between these parked cars (the parking of which would be delineated by the addition of a new proprietary plastic kerbing or like) and the existing kerb.

This would also be facilitated by the installation of additional concrete traffic islands in the immediate proximity of the lights-controlled pedestrian crossing of Annerley Rd in front of the Mater Hospitals complex. These new traffic islands are intended to ensure motorists correctly follow their lanes and do not drive into the rear of parallel parked cars.

Attached with this letter is an amended version of the project plan reflecting these proposed changes.


