Dear Dr Bean 

Thank you for your email of 3 January 2019 about GIS data on bikeways and bike racks on Council's Open Data website. I also acknowledge your email of the same date in relation to the kiosks next to the Go-Between Bridge.

I asked Ms Chloe Wright, Strategic Planner from Council's Transport Planning and Operations (TPO) to investigate the status of the bikeway count data.

Ms Wright has confirmed, and as you have likely seen, the 2016 manual survey data was published online last month and can be accessed via Council's Open Data website at www.data.brisbane.qld.gov.au. Ms Wright also advised that TPO is reviewing the 2017 bikeway counts and Eco-Counter data and it is anticipated that it will be completed this year.

If you have any further enquiries regarding bikeway counts, please contact Ms Wright on 3178 7190.

I can also confirm the December 2018 Open Data for CityCycle, including membership, trip numbers and station locations, was published in mid January via the above portal.

As you are aware, the CityCycle Ambassadors program encourages Council staff to use the CityCycle scheme. Since the program commenced in January 2017, there has been 530 sign-ups. As this program is for Council employees, there are currently no plans to publish user statistics on Council's Open Data portal.

Thank you for your continued interest in the kiosks located on the Bicentennial bikeway. As you are aware, Council was due to conduct a tender process to identify a new community organisation to manage the kiosks in June 2018.


Unfortunately, due to the priority of other vacant community facilities, Council did not complete the tender process at that time. Council is committed to identifying an appropriate lessee to manage the kiosks into the future and will be calling for tender applications late this year.
