Thank you for your letter of 5 October 2019 which referred to your earlier correspondence regarding the Wilson Outlook Reserve.

My commitment to you in my letter of 23 August 2019, in relation to the upgrade of the cycle path and the relocation of the existing light pole, will be met. I am advised that the work is scheduled to take place by the end of November 2019.

I am further advised that the delay was caused by the Wilson Outlook upgrade being split into two work components due to timing, one being the delivery of the park land upgrade ready for Riverfire, and the second, post Riverfire, the upgrade of the cycle path.
