Dear Mr Bates / Mr Chandler-Mather

We would first like to congratulate you on being elected to the Federal Parliament. We write to you in your capacity as the Federal Member for Brisbane / Griffith regarding Brisbane City Council's "Green Bridges Program" and the need for Federal funding to support this program so it delivers the new active transport infrastructure much needed by Brisbane residents.

As background for you, the Brisbane Central Business District Bicycle User Group (CBD BUG) is a grass roots volunteer organisation of more than 700 members, representing the interests of the very large number of people riding bicycles to, from and within the Brisbane city centre. It is active in seeking policy decisions at all levels of government supporting people who want to cycle, and in particular relating to improved infrastructure, end-of-trip facilities, integration of cycling needs with other transport modes and a regulatory environment friendly towards people riding bikes. CBD BUG members meet monthly to exchange information and ideas, discuss issues of relevance and determine the direction of policies to benefit CBD cyclists.

As you would be aware, the CBD BUG is a strong supporter of Lord Mayor Schrinner's "Green Bridges Program" for Brisbane. Since the program's announcement, the western suburbs bridge has been "scrapped" due to local community opposition. In lieu of the western suburbs Brisbane City Council were investigating alternative locations for the 5th bridge with one linking New Farm/Teneriffe to Hawthorne/Bulimba.

Public records indicate a bridge crossing the Bulimba reach of the Brisbane River has been discussed as early as 1885. The CBD BUG and other active transport groups/advocates have been vocal in supporting a bridge at this location for its ability to move thousands of people every day and reduce motor vehicle traffic between congested eastern and northern suburbs roads while avoiding costly and economically irresponsible road widening projects. Indeed, a Brisbane

City Council response to a September 2020 petition indicated Council was considering "locations east of the Story Bridge" (https://www.epetitions.brisbane.qld.gov.au/petition/view/pid/927) and also seeking a Queensland Government study that they have since received and is now publicly available (https://www.tmr.qld.gov.au/_/media/aboutus/rti/disclog/2021/rti-1706-released.pdf?sc lang=en&hash=30E337046642BCEA37B712EA1978EF23)).

Brisbane City Council is seeking funding support from other levels of government to complete the program (refer Figures 1 & 2). As a local Federal member, the CBD BUG seeks your public support for:

- 1) the construction of a "Green Bridge" or other form of active travel crossing spanning the Bulimba Reach of the Brisbane River, and
- 2) funding from the Federal Government for this project.

In mid-2021 we wrote a similar letter to your predecessors (Figure 3&4). Unfortunately, we never received a written response, but we anticipate you will be more supportive of this project.

We look forward to your response and would very much welcome an opportunity to discuss this much needed infrastructure with you.

Bicycle Queensland Queensland Walks Construction on two green bridges linking Brisbane's inner-city suburbs is slated to begin this year, but the location of three other planned bridges remains unclear.

In 2019, Lord Mayor Adrian Schrinner made a \$550 million pledge to build five new green bridges, catering for pedestrians and cyclists, to reduce vehicle traffic and improve the city's connectivity.

At Tuesday's public and active transport committee meeting, Brisbane City councillors were given an update on the progress of the green bridges program.

Public and active transport committee chairman Ryan Murphy told the committee the council wanted state or federal funding support alongside the \$550 million already committed.

Key points:

- Brisbane City Council pledged
 \$550 million for five green bridges
 in 2019
- Two bridges begin construction this year and two others are out for consultation
- A planned bridge at Bellbowrie has been scrapped

"I think everyone can agree this program has come a long way from when it was announced in March [2019]," Cr Murphy said.

The \$190 million Kangaroo Point green bridge will be 470 metres long and 6.8 metres wide, with separated cycling and pedestrian lanes, linking the inner-city suburb with the City Botanic Gardens.

"Our city has sustained a brutal economic hit this year, but my administration is determined that we build for the future. This means we get people into work now and critical infrastructure projects like these bridges are how we do that," he said.

"Kicking off this procurement process quickly is also about breathing life into the local construction industry and expanding supplier opportunities for struggling businesses."

The lord mayor said discussions were continuing with the state and federal governments over additional funding for the the LNP administration's bridges program, hampered by the delays in releasing government budgets due to the COVID-19 pandemic.

Geotechnical work on the Kangaroo Point bridge location is under way and the council says both bridges will support about 500 jobs during construction.

But council opposition leader Jared Cassidy said the budget announced for the two bridges was a "cost blowout".
